PRE-QUALIFICATION INSTRUCTIONS

1.1 Introduction

Wanandege Housing Limited would like to invite interested candidates who must qualify by meeting the set criteria as provided by the procuring entity to perform the contract of supply and delivery or provision of goods and services.

1.2 Objective

The main objective of pre-qualification of suppliers is to supply and deliver assorted Goods and Services under relevant Tenders/quotations to Wanandege Housing Limited as and when required.
